RFP Requirements

Proposal submissions should include:

- Firm background and experience with not-for-profit and federally funded contractors.
- 2 most recent peer review reports.
- 2 client references from the non-profit and/or government contracting industry.
- Audit approach and expected timelines for completion.
- Partner / Staff Qualifications and experience. The firm should identify the principal supervisory and management staff including engagement partners, managers and other supervisory staff or specialists. Please include biographies with related audit experience in government contractor accounting, professional memberships and any specialized training or education applicable to the engagement.
- Fee structure for services noted above for each of the fiscal years ending 12/31/24 – 12/31/26.

RFP Timeline

Written proposals will be accepted until 5:00pm June 28th, 2024. Submissions should be submitted via our online proposal submission portal.

GI executive management will present all submitted proposals to its Audit and Finance Committee for review during their July 2024 committee meeting. At least three firm finalists will be selected by the committee who will be invited to present at a virtual Q&A with the Audit & Finance Committee in August 2024 for final section.

Evaluation Criteria

GI will evaluate each proposal on the basis of the professional qualifications of the firm and assigned personnel as well as the relevant experience in nonprofit
